| 1. | Warsaw | 22.02.2010 | Anti-Semitic content presented on the website www.demotywatory.pl . | The Foundation reported the act to the Area Prosecutor for Warsaw-Śródmieście district. After the authorities decided to not to launch proceedings, the Foundation filed a complaint which was approved. The owner of the website was called on to remove the disputed content. The investigation is underway. |
| 2. | Warsaw | 03.03.2010 | Devastation of the lapidarium through the drawing of anti-Semitic content. | The Foundation reported the case to the Area Prosecutor for Warsaw-Praga Północ district. After the authorities decided to not to launch proceedings, the Foundation filed a complaint which was approved. Later, the case was closed due to the failure to detect the perpetrators. |
| 3. | Jarosław | 08.03.2010 | 5 trees cut down and stolen from the Jewish cemetery. | The case was reported to the Area Prosecutor in Jarosław. After the authorities decided to not to launch an investigation, the Foundation filed a complaint which was approved. The investigation was opened and soon discontinued by the Prosecutor's Office. Again, a complaint was filed by the Foundation against the discontinuation, and a decision to discontinue the investigation was revoked by the court. |
| 4. | Biłgoraj | 29.03.2010 | Damage of the gate leading into the Jewish cemetery. | The Foundation reported the case to the Biłgoraj Police Department. The authorities decided to discontinue the investigation and |

| 5. | Szczebrzeszyn | 13.05.2010 | Devastation of the Jewish cemetery, overturned and broken matzevot. | The Foundation reported the case to the Area Prosecutor in Szczebrzeszyn. The investigation was discontinued due to the failure to establish if the damage was caused by forces of nature or human actors. |
| 6. | Ziębice | 18.05.2010 | Drunken excesses in the Jewish cemetery, as seen in a movie on the Youtube website. | The case was reported to the Ziębice Police Department. Charges were made against three perpetrators. |
| 7. | Debrzno | 23.06.2010 | Paint spilled over a memorial and lapidarium in the Jewish cemetery. | The Foundation reported the case to the Area Prosecutor in Złotów, which resulted in the launching of an investigation by the prosecutor's office. |
| 8. | Suwałki | 23.06.2010 | Devastation of the Jewish cemetery, overturned and broken matzevot. | The Foundation reported the case to the Area Prosecutor in Suwałki. The case was discontinued due to the failure to detect the perpetrators. |
| 9. | Leżajsk | 07.07.2010 | 5 sections of fence stolen from the Jewish cemetery. | The Foundation reported the case to the Area Prosecutor in Leżajsk. After the authorities decided not to launch proceedings, the Foundation filed a complaint. The decision not to launch proceedings was revoked by the court. |
| 10. | Augustów | 02.08.2010 | Devastation of a memorial plaque at the Jewish cemetery. | The case was reported to the Area Prosecutor in Augustów. |
| 11. | Łańcut | 07.10.2010 | Damage done to the lock in the door of the synagogue. | The Foundation reported the case to the Łańcut Police Department. The culprit was apprehended and convicted and the case closed. |
